



Block Map




<u>Project No.01- APPI-</u> Strengthening Gram Sabha to ensure community forest right (CFR) and other social welfare scheme.

Executive summary of the project:

This project will be conducted for a period of three years (September 2022 to September 2025) across 57 villages under 5-gram panchayats in Manatu block in Palamu district of Jharkhand. The rural households of the selected area are facing a large number of socio-economic problems including poverty, drought, ground water depletion, lack of clean energy sources, crop failure, food & nutritional insecurity, irregular PDS system, poor quality of government service delivery through social security schemes, unemployment, indebtedness and painful migration. Looking the worst situations, we have implemented several activities effectively to reduce the problems of the targeted households.

The overarching objectives of the project is to strengthen the local self-governance structure by strengthening Gram Sabha, ensuring rights & entitlements through social security schemes, wage-based entitlements through MGNREGA, community & individual claim filing under FRA act, 2006, intervention in PVTG communities in three verticals of health & nutrition, conserving the traditional culture & systems, livelihood generation.

CADRE TRAINING of 57 villages from 05 GPs

This training objective is to enhance the capacity and knowledge on MGNREGA, Ration and Pension and about its MIS. This training enables cadres' knowledge of digital access and information related to social security schemes to ensure participants contribute to the community (beneficiaries) who is not able to access digital information on real time. So, cadres track the status of ration card, NSAP and MGNREGA job card by MIS.

In this training there was a discussion mode exercise related to Village level problems, their solution and challenges and after orientation about Gram Panchayat Development Plan (GPDP) and how we can effectively use GPDP make village developed and self-sufficient.







Discussion on Social Problems & Solutions:

Participants (Cadres) responses on the discussion sessions on the Social problems majorly identified in respective villages, their probable actionable to resolve the issues and key challenges faced. This was done through discussion mode and responses noted during training. January 2025 Cadre Training I conducted a session through discussion related to Village/Tola level prioritized problems. The cadres shared their experience one by one which problems prevalent in their respective village. These are the response shred by the cadres. After the discussion we also discussed cumulatively on their solution mechanism.

This training enables Village heads to ensure participatory planning for village development and track the progress of work through digital information access for transparency and good governance and strengthen the local democracy.

Training

In the meeting discussed importance of GPDP, e-Gram Swaraj Portal, Jal Jeevan Mission, Forest Management Plan and strategy Discussion on Reaching to vulnerable (Actual Beneficiaries) population and status was presented. After details discussion, we move on to the MIS part that how data can have accessed and tracked by the respective MIS associated to the portal like GPDP, e-gram Swaraj, Jal Jeevan Mission. There is hand to hand trail of tracking data and information so that participants were fully acquainted to run smoothly to the MIS.

Supplementary Nutrition Distribution to PVTGs Families:

There was 300 families in 05 GPs of Manatu having PVTGs families and in the month of April 2025 supplementary nutrition provided to the 236 PVTGs families in 05 Gram Panchayats of Manatu Block. This initiative will be helpful to curb the malnutrition among the communities residing in remote areas not accessible to proper nutrition and education helps in proper development of the PVTGs families and children.

Overall Objective

The requirement for the large investments for the community development projects, primarily in disadvantaged communities, is high. More often than not, such projects require investments much beyond the donor funding. In this scenario, leveraging Mahatma Gandhi NREGA fund works out to be a useful source for financing large community projects.

This project aims to enhance the technical capacities to implement the program at the block and gram panchayat levels and thereby increase the scale of MGNREGA works, reduce delays in wage payments to workers and improve the quality of assets constructed under the program.

Orientation Program at Block level

Block level orientation program with BDP, BPO, GRS, JSLPS and all Mukhiyas regarding introduction of CFP.

Aapki yojna Aapki Sarkar Aapki Dwar

Participation in Aapki yojana aapki sarkar aapki dwar and interact with villagers and aware people about CFP and discuss about village problem related to MGNAREGA.

Developing GIS (Geographical Information System) based plan

Preparation of GIS based NRM (Natural Resource Management) plan is under process in two blocks. GIS-based plan will be used to identify specific MGNREGA projects based on the priorities and needs identified, considering the potential for sustainable asset creation, natural resource management, and livelihood enhancement. GIS based plan will also be used to identify suitable sites for MGNREGA projects, such as water conservation structures, rural roads, afforestation, and livestock management.



DPR preparation

- PRA exercise in which they prepare social and resource maps of that village with the help of villagers.
- Transect walks for proposed activities with GIS based planning in which sites visit with the help of villagers and taking let long at particular activity.

Awareness Generation & sensitization of GP functionaries

Special focus has been put on mass awareness generation, particularly among the SC ST community to enhance their overall understanding regarding the rules & regulations of MGNREGA Act, their rights & how to take advantage of the scheme.



Continuous sensitization has been done for the GP functionaries, including elected representatives, Panchayat Secretaries, and other officials involved in MGNREGA implementation on various aspects of MGNREGA, including its objectives, provisions, rights

and entitlements of beneficiaries, roles and responsibilities of GP functionaries, project planning and management, social audits, and grievance redressal mechanisms.

Program Actions and impacts:

Staff Training on GPDP in Ranka, Garhwa:

In this GPDP training which was held on 19/01/2025 05 Panchayat Coordinators, 01 Block Coordinator and 12 Community Resource Person participated and GPDP stands for Gram Panchayat Development Plan. It's a comprehensive, participatory plan developed by village panchayats (local councils) to address the specific needs and priorities of their communities. The GPDP aims to guide development initiatives and ensure the effective utilization of resources for the overall improvement of the village.

Staff Training on MGNREGA at Block

Participated in a training program on MGNREGA for our field staff on 13th January 2025 to 15th January 2025 for 3 days. As we all know that MGNREGA is the India's biggest employment generation program. MGNREGA provides a legal guarantee to a person for wage employment. In this program we talked about how it comes and what were the committees

who initiated this program. What will get a person through MGNREGA and who is eligible for this, how can one can get employment, what are the procedures to make a MGNREGA job card, what is the wages rate and how can one get his wages, if anyone has complained on any issue where he can register them complain everything were discussed in this training. A one-day Program in block was also organized on 28/12/2024 for our staff members on MGNREGA in Block.

Project No. 04 - Gram Swavlamban- A new approach to poverty alleviation.

Executive summary of the project

Despite so much of investment in poverty alleviation, the desired result is yet to be achieved. It is one activity that has been undertaken since independence through Planning Commission (now NITI Aayog). Several departments & NGOs are also working with the same motive but in isolation. Poverty is multi-dimensional and which dimension comes first; nobody knows. Looking from the bigger prospects, the basic reasons behind the backwardness are illiteracy, unemployment, debt, diseases, malnourishment, superstition & social evils, etc. resulting in the lack of awareness, unity, community ownership & leadership, poor access to entitlements and skill enhancement. Even today's trend of development is zeroed to tangible assets only but it is useless to keep anything in a vessel except the right one. In the route of advancement, inner self-development and building the self-esteem of the villagers and their self-reliance has never been focused leading to the poverty even after seventy years of independence. There is a need to invest in unification of the villages irrespective of their caste, creed, religion and gender.

Regular Gram Sabha with Resolution

Communities of that area have decided to conduct Gram Sabha every month and rises problems of different aspects and come into resolution in this meeting.

Shramdaan days/week

To uplift the condition and look into different perspective of village villagers of that area decided to give Shramdaan to solve different institutional and noninstitutional issues.

Daily sweeping/brooming (days/week)

Cleanliness is next to godliness, all villagers keep in their mindset about this thought, so that the communities have decided to do sweeping and brooming throughout the Tola/village.

Panch Sutra of Cleanliness

Villagers of that area have taken pledge that they will use Panch sutra for cleanliness like make Soak pit in every Household, make compost pit in every Household, Plastic Management, Ecofriendly Dustbin, Toilet use etc.

Education

Recognizing education as a foundation for empowerment, villagers are actively enrolling children in schools, preventing dropouts, and promoting adult literacy. Community members also conduct monitoring visits to schools to ensure accountability.

Health related issues

Efforts are underway to promote institutional deliveries, improve maternal and child health, and encourage the creation of nutritional gardens in households for better dietary diversity and food security.

Other Initiatives

Villagers are working Chil labour Free, early marriage free village, they are controlling domestic violence, adult education campaign, mango plantation, awareness on chemical free farming.

Claiming Community Forest Rights through strengthening of Gram Sabha to ensure CFR

Distribution of Cricket Kit to Birsa Munda Youth Club


